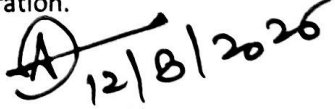

5. Statutory Guidelines & Code of Conduct

- **Eligibility & Disqualifications:** Contesting candidates must belong to the respective constituency as per the registered Bye-Laws and fulfil criteria under Sections 29, 43, and 44 of the MSCS Act, 2002.
- **Central Government Employees:** Contesting Central Government employees must submit prior permission from their competent authority under CCS (Conduct) Rules, 1964 in Annexure-V at the time of nomination.
- **Model Code of Conduct:** Society vehicles allotted to office bearers shall not be used for election canvassing. Board meetings convened 30 days prior to polling require prior written approval from the Returning Officer for agenda items.
- **Election Expenditure:** Candidates must maintain accounts of election expenses as per MSCS Rules 19(U), (W), and (X) and submit them within 30 days of the result declaration.
